It is pointed out that units of the HPSEB Pensioners Welfare Association and individual pensioners are approaching the State Body of the Association and the Accounts wing also about the non-payment of medical claims for the last six months and more.

It was decided in one of the meetings earlier in 2012 that every year in the month of April, initial drawing limit, specifically for the payments of medical claims of pensioners on the average of previous year will be revised/fixed but it appears that has not been done this year.

As you know that pensioners being in old age which is itself prone to different ailments/serious diseases and the medical treatments costs have rocked to sky,

therefore, the pensioners cannot afford to delay in payment of their claims from Board.


It is, therefore, requested that the drawing limits to the Divisions pending for revision with F&A wing may please be released at the earliest.

Secondly, as pointed out by many pensioners who opted for payment of medical claims from F&A wing, their Medical Bills are pending since May 2023, in the F&A wing, which may please be passed and release the payment at the earliest.

Prior to about six months, the payments of medical claims in general were regulated properly/timely from the field units/Divisions of the Board and particularly from the F&A wing.

Kindly arrange to pay the pending medical claims of the pensioners at the earliest please.
